CASE OF HYDROPHOBIA.

QUEBEC, MAY 27. Mailame Bruncau, wife of Mr. ----Bruncau, of the ordnance department, had her arm violently lacerated by the bite of a cat, about the commencement of November last. The animal fastened on her with such feroeity, that it would not loosen its hold until some of its bones were broken-it was immediately killed. The laceration was washed with brine, and dressed with some domestic remedy, such as the family had been in the habit of applying to wounds and sores. It continued open for several weeks, and healed at last with much difficulty. About the beginning of May, the scars became inflamed, and very itchy, attended with a sort of pinching pain, which extended in the direction of the lymporties to the exilla, and side of the neck. On the morning of the 12th, when attempting to take a little cordial for the relief of a pain in her stomach, she found herself seized with an indescribable feeling of horror, and constriction of the throat, as the liquid approached her mouth: attributing this to the smell of the cordial, she tried a little tea, and afterwards some water; but the same

feeling was excited the instant she looked at either of these. Her husband, being employed in the ordnance, sent for a medical officer of that department, who immediately attended, and after much enquiry, obtained the history above related of the case.

Care was taken in putting the necessary questions to the husband, that the patient should not hear them, in order that she might have no suspicion of the real nature of the disease; she, however, overheard some conversations that were made about the cat, and instantly exclaimed, "Ce n'est pas cela car mon enfant a ce. mordu dans le meme tems que mor." On Thursday last the ship Canton Packet Capt. Proctor, cleared for India and China. Her loading, we understand, consisted principally of lumber for the Isle of Franceand she had on board about \$300,000 in specie, to be invested at Canton. She was at anchor off the long-warf, and would have sailed this day or tomorrow, if the wind had proved favorable.

Yesterday, about 11 o'clock a quantity of powder, (said to amount to two or threekegs,) situate near the cabbin, exploded, with a concussion that shook the houses in town, blew the quarter deck of the ship to a great height in the air, drove out the quarters and stern, threw the mizen-mast against the main yard, and set the ship on fire. Assistance was soon afforded from the shore, and from the United States ship Independence. The cable of the Canton Packet was cut, and she was towed into shoal water, where she filled, and the fire was extinguished.
