

Nashville. NASHVILLE, JUNE 12.

On Wednesday last, about 3 o'clock P M James Monroe, Esq. President of the United, States, arrived in Nashville He left the residence of Major Géneral Jackson on the morning of that day, accompanied by the General, his staff, and Major General Gaines. He was met by a committee, consisting of E. H. Foster, (mayor,) John McNairy, John H. Eaton, J. C. Bronaugh, John Somerville, W. B. Lewis, Samuel Hogg, Felix Grundy, Henry Crabb, O. B. Hayes, and Alfred Balch, who, in behalf of the citizens, invited him to partake of the entertainments prepared for his reception. A few miles from town he was received by a body of volunteers, under the orders of Colone:s Williamson and Phillips, and a large collection of citizens on horseback, who escorted him to town.

The Cumberland Lodge of Masons, in the habiliments of their order, accompanied by a band of music, met the procession on College hill, where the Worshipful Master addressed the President, and weicomed him as a brother of the craft. After receiving his answer, the fraternity preceded the procession they had met, and conducted the distinguished guest to the residence of E. H Foster, Esq (the Mayor of the city.) whose hospitality had induced him to offer the entire occupancy of his house as suitable lodgings for the Chief Magistrate, during his sojourn amongst us. The hail was of the size of ounce bullets-many twice as large, measuring from three to four inches in circumference. We have not heard of the loss of any lives, though of many bruises and hair-breadth escapes. Many horses and cattle received injury, and some were killed.

This hasty sketch, we are confident, will give distant readers but an imperfect idea of the appearance of the storm, or of the consequences resulting from it. This cause was tried before the honorable udge Van Ness, for damages against the defendant for having issued out an attachment against the property of the plaintiff during the time he was on business in Charleston, S. C. and having notice thereof published in the public newspapers, under the "act for relief against absconding and absent debtors "

The leading circumstances in this case appear to be as follows:

The plaintiff had purchased goods the property of the defendant, and had given his note with an approved endorser, for the same; he then publicly left the city for Charleston, S. C. leaving his dwelling house furnished and his clerk in the counting house to attend to such business as should be required ; he also appointed a respectable mercantile house as his agent to whom he remitted funds to pay all his engagements during his absence, except the note to the defendant, relying that the endorser would honor it, as the goods for which it had been given, were purchased on their joint account, and placed in the hands of the son of the endorser in Charleston, S. C. for the purpose of remitting the proceeds to his father to pay the note, instead of which a new note was given by the endorser at 60 days, leaving the old note in possession of the defendant, who, before the same was due, sued the plaintiff at Charleston, S. C. on the old note and issued out the attachment in this city against his property, and advertised him as an absent debtor.
