FROM PORT AU PRINCE.

SAVANNAH, DEC. 5.

Captain Douville, of the schr. Katy, arstates that on the 13th ult. when he left that port, every thing was tranquil. Boyer was at the Cape with 25,000 troops, but he met with no opposition, and the change of government was rapturously hailed wherever he appeared. All the branches of the Royal family had received his protection, and moderation and humanity characterized his proceedings. We have not perused any later papers than to the 26th October; but this verbal intelligence can implicitly be relied on, and is highly satisfactory.

From the papers received by the Katy, we have made the following translations: From the Port au Prince Telegraph, Oct. 26

Death of the Tyrant and the end of Tyranny. His Excellency the President of Hayti made his exprance into St. Marcs the 16th inst at 9 o'clock in the morning. He was received with a pure and unaffected alacrity. The inhabitants call us their liberators, the saviours of their country. Every species of misery, suffering, and degradation, to which human nature is liable, was presented in this city. Never was tyranny more cruel, nor more savage than that exercised over the unfortunate inhabitants of the North and the Artibonete. The crimes committed by Christophe are innumerable, and their recital would be disgusting. Wherever the army passed nothing was seen but women and a few old men. The population of this part of the Island was destined to perish. Increase was impossible. His Excellency received a communication on the 15th inst. signed by 4 chiefs who are at the head of the Revolution; Richard, Monpoint, Placide Lebrun, and Charles Purre. They report that on the 8th inst. Christophe dispatched against them his domestic Garrison, who, as far from fighting, united themselves with those who had raised the standard of Liberty. Joachim Deschamps, the commander of this corps, and worthy to be the friend of such a master, seeing himself abandoned, sought safety in flight. The Royal family were at the mercy of the Republicans.

The month of October will be ever me-

morable. In the space of fourteen years it has twice seen liberty triumph over tyranny, and two despots sink beneath the efforts of the Republicans. On the 8th of the month Christophe the Cruel blew out his brains

Romain has not surrendered himself, as was said. This chief is in a state of rebellion, and endeavoring to create a party — He cannot however, succeed, as the few who were with him are daily deserting to us .-There were 4000 men in the dungeons and prisons of Sans Souci. They have been liberated.

From the Boston Daily Advertiser of Dec. 6. Yesterday morning at half past six o'clock, an explosion took place at the extensive Pow-der Manufactory of Messrs. Moses Hale & Co. at Chelmsford. We have to announce the melancholy fact, that John Ives, of Sunbury, and Levi Marshall, of Chelmsford. were instantly killed, and Nathaniel Marshall, a brother to the last, and Sherburn Chase, of Litchfield N. H. were dangerously wounded. These were workmen, and entered the mill but an instant before the explosion. The loss of property is comparatively small, less than \$1000, as the Stamping Mill and Corning house only blew up.

The magazines, and other buildings, in which were the principal quantities of pow-der, being at some distance remained unin-jured The two buildings which blew up were about fifteen yards apart. It is impossi-ble to determine at present which first exploded, or what was the cause. We understand, that this accident will not materially interrupt the business of the establish-

BARTIMORE, DEC. 11.

A most daring fraud was, on Saturday last, committed in his city. The circumstances as stated to be are shortly these—that a young black man exime to Baltimore, sold his flour in Howard street, and received a bank bill in payment to the amount of fifty dollars. He was shortly afterwards accosted in the street, by a man, assuming the name of a magistrate, who told him, that it became his duty in virtue of his office to examine the bill, to ascertain whether it was genuine or not. The unsuspecting man de-livered into the hands of the stranger, the envelope containing the bill, which this pre-tended magistrate shortly afterwards return-ed, affirming the note to be genuine. The young man afterwards on opening the packet, found that this pretended justice had escaped with the fifty dollars, leaving only one be-hind to remind the owner of his loss [Chronicle.

NEW YORK, DEC. 9. Almost incredible, and yet true - We were among a number who yesterday went on board the British schooner Parker, captain Dunn, from Jamaica. to see the Sword of a Sword Fish. This sword appears about nine inches clear of the ceiling of the vessel, in the bilge, having penetrated through a four inch plank and sheathing, passing between the timbers and through the ceiling. Had it gone two inches farther, it would have penetrated a hoghshead of rum. I am sorry that there is so much need of he admonitions I am about to give .- Depend on it, you do not "work it right," you would make your farms and stocks twice as profitable as they now are. Many of you farm too much.—
You would find it much more profitable to farm twenty acres well, than forty by halves. corn to the acre. Is not this much better than a common crop of thirty or forty bushels? You will most certainly say it is, and with the same breath ask how I manage to make it produce so plentifully? My ground being much infested with ground mice, or moles, and also overrun with grubs and other vermin, I put on, early in the month of vermin, being an excellent strong manure; over and over, until it became completely mellow; I then had every corn hole filled with hog manure, and after drepping my corn. (which had been previously soaked in warm water) I scattered a pint of lime over every hill, and then covered the whole with a little done two or three weeks before many others. This is accomplished in a great measure by redeeming time; rising between three and & o'clock in the morning; then if the day be very sultry and hot. I lie by from 12 to 3, and rest. I then feel refreshed and able to work until quite dark-This I call "working it right" Whereas, should I lay in bed until at night, drink too much whiskey, but half manure, half plough, half plant, half nurse, half harvest, and do every thing else by halves, I surely should nor "work it right,"

nor get half a crop.
I shall now conclude, by giving you, for further consideration, a few excellent observations, from a wiser head, perhaps, than my own, which I shall endeavor to improve for myself, and hope every brother farmer will do likewiee, viz.

this department on that subject.

In relation to that part of the resolution which requires any information this department may possess showing that corporal pu nishment has been inflicted on any soldier, whereby he came to his death, I have the honor to state that the only report of that kind, which has reached this department, was the case of a soldier at Fort Preble, near Portland, in Maine. Major Brooks, a correct and intelligent officer commanding that post in September last, reported that the death of a soldier, an habitual drunkard, who had been on a fatigue party, under Lieut. Hobart, and had been confined by him, had caused much excitement among the citizens, who attributed the death of the man to the conduct of Lieut, Hobart; that the civil authority had taken up the affair for investigation, to which Lieut. Hobart had readily submitted himself. The report was accompanied with the enclosed certificate of the jury of inquest as to the correct conduct of Major Brooks and the other officers of the post, in relation to the transaction .-It thus appearing that the affair would undergo an investigation in the District Court of the United States, the department did not think it proper to order a military investiga-

Perthshire from Savanilla. The only intelligence, however, that we find in these papers on the subject is contained in the following extract from the Kingston

Chronicle of the 6th November. By the Perthshire, which arrived here from Savanilla on Friday last, we have received various particulars of the relative situation of the contending parties in New Grenada, &c. By sea, at the earliest dates of our letiers, 28th September, the Spaniards were completely masters of the Inde-pendents. The Ceres corvette, which afterwards called at Port Royal, sailed out of Carthagena in face of the blockading equadron, who could not touch her.
