THE CONTEST OF 1848 .- However strong may

Post":—

The Contest of 1848.—However strong may be our confidence in the continued ascendency of the Democratic cause, it may perhaps be idle at present to put forth any predictions of our own, concerning the final result of the approaching struggle. Even to speculate upon the character which the canvass may yet assume may only serve to illustrate hereafter our own conceit and folly. But, although the greatest proficient in politics cannot, at this moment, foresee the occurrences of the campaign, or forstell its event, still we think that the great elements which are to enter principally into the contest, and probably decide it, are becoming apparent to us all.

Whether there shall be war or peace will not, we believe, materially change the position of the Democracy, or the "platform" of the Whigs.—With the former, there will be an unwavering adherence to well-understood and long established principles, and to that comprehensive system of public measures with which the Democratic party of the country has now become fully and proudly identified. There will be no surrender on our part of any great principle—no retreat from a single position we have already taken. The grounds we have assumed heretofore, we shall maintain now, whatever new and equally important issues a national necessity, may force upon us. The opposition, whether there be war or peace with Mexico, will continue its warfare upon the Administration and its entire public policy.—It matters but little, truly, what its immediate object may be; whether to embarrass the President in his successful prosecution of the war, or defeat him in the establishment of an honorable peace. Revolutionary Europe is, for the moment, comparatively quiet. After the late hurricane that so unceremoniously levelled thrones and changed empires, there is a temporary calm, but every day produces some event of deep interest.

In England and Ireland, no revolution has as yet happened; the people are, however, silently at work, and their labor will by and by produce a change. You would not come to this conclusion by reading the English Journals. During a residence of eight years in London, I have never been so utterly astonished at the ignorance of the British Journalists as to the present social state of Great Britain. They represent every thing in the brightest colors, and would make it appear that England never stood firmer—that the government was never so strong as it is now. Foreign countries are greatly deceived by the England that England never stood firmer—that the gov-ernment was never so strong as it is now. For-reign countries are greatly deceived by the Fng-lish journals. In England and Ireland there is a strong power at work, in the hearts and hands of the people, that will soon show itself in deeds, not words. Yet the journals boast of the strength of the government and the throne. In England and in Ireland, the people—that is the middle and working classes—see treated with

he middle and working classes—are treated with contempt by the Government and its organs, and he people not only know it, but feel it, and they contempt by the Government and its organs, and the people not only know it, but feel it, and they have resolved to talk and petition no longer.—
They are now at work; they are arming, and a day will soon come when they will show their weapons and use them—unless the Government, alarmed at this powerful opposition, grants great Reforms. But the Government distinctly says, that it will not do so. It will neither listen to the voice of the people of England, nor to the cry of Repeal in Ireland. The result will be a Revolution, an onthreak in Ireland, when hundreds will be shot down, but thousands will take their places. Riots will follow in England, and in London 200,000 poor and suffering men will rise up and demand their rights, or overthrow the government. I speak not of O'Connors nor O'Connells—of Chartists nor Repealers. The people of all creeds will accomplish all. Therefore do not place confidence in the triumphant tone of the Government organs, for they are totally blind to passing events immediately before them.

Parliament has adjourned till the 1st of May, and it would be difficult to discover any measure of general advantage to the country that has been

Parliament has adjourned till the 1st of May, and it would be difficult to discover any measure of general advantage to the country that has been carried out during the session thus far clapsed. Many fine promises were made but none have been fulfilled, and it is the same throughout every session. This is the cause of the present dissatisfaction, not only among the much abused Chartists, but among the middle classes. One subject in which our country is interested deserves attention. It was stated in the beginning of the session that the navigation Law would be considered at an early day, and yet up to the present time, nothing whatever has been done. The Morning Chronicle, alluding to "a remarkable correspondence" that had taken place between Lord Palmerston and Mr. Bancroft, on this subject, remarks that "in a liberal and enlightened spirit the American Government had proposed the mutual removal of existing restrictions on international commerce, which, in their opinion, had done no good to either country, and to abrogate which, would, they considered, at once set free dormant commercial wealth, without injuring any one." The advantagea of closing with such an overture was sufficiently obvious, and it failed not to meet a warm response from Lord Palmerston. Yet, exclaims the Chronicle, nothing, whatever has been done.

For many years our citizens have been subjected to repeated INSULTS AND INJURIES; OUR VESSELS AND CARGOES HAVE BEEN SEIZED AND CONFISCATED; OUR MERCHANTS HAVE BEEN PLUNDERED, IMPRISONED, MAIMED, WITHOUT CAUSE, AND WITHOUT REPARATION. At length your government acknowledged the justice of our claims, and agreed by treaty to make satisfaction, by payment of several millions of dollars; but this treaty has been violated by your rulers and the stipulated payments have been withheld. Our late efforts to terminate all difficulties by peaceful negotiation has been rejected by the dictator Paredes, and our minister of peace, which your rulers had agreed to receive, has been refused a ers had agreed to receive, has been refused a

lers had agreed to receive, has been refused a hearing."
So spoke Gen. Taylor, but how speak those Whigs who profess to be anxious to make him President? They say the war "is unjust and unrighteous," and that there was no good cause for it. They care not how much Gen.
