New York was equally cautious with Virginia, in acceding to the federal compact ; and in ratitying it, made similar solemn declarations. We quote as follows :.

"We, the delegates of the people of the State of New York, duly elected, and met in convention, having maturely considered the Constitution of the United States of America, agreed to on the 17th day of September, in the year 1787, by the (general) convention then assembled at Philadel phia, (a copy whereof precedes these present,) do leclare and make known :

. That all power is originally vested in, and consequently derived from the people; and the government is instituted by them for their comon interest, protection, and security.

That the enjoyment of life, liberty, and the pursuit of happiness are essential rights which every government ought to respect and preserve.

" That the powers of government may be resumed by the people, whensoever it may become necessary to their happiness, that every power, juris-diction and right, which is not by the said Constitution clearly delegated to the Congress of the United States, or the department of the government thereof, remains to the people of the several States, or to their respective State governments, to whom they (the people) may have granted the same. And that those clauses in said Constitut on, which declare that Congress shall not have or exercise certain powers, do not imply that Congress is entitled to any powers not given by the said Con-stitution; but such clauses are to be construed either as exceptions to certain specified powers, or, as inserted merely for greater caution, &c.
