We made the trip at easy stages of about tweety-five miles per day, and reached the city of Mexico on the eve-

STAY LAW.

The Sentinel understands that the following bill, which passed both Houses of the Va. Assembly on the 19th inst., is a temporary measure designed to stay.legal proceedings for the collection of debts until the main bill reported by the chairman of the committee of Courts of Justice can be matured and passed :

Be it enacted by the General Assembly of Virginia, That no executive, venditioni, exponas, attachment, or other process, to compel the payment of money or the sale of property for that purpose, shall be issued ; or if heretofore issued, shall be proceeded with; and that no judgment, decree or order for the payment of money, rendered or made during the period this act is in force, shall operate as a lien upon any estate held or owned, or any interest in such estate by the person or persons against whom such judgment, decree or order may be rendered or made, nor shall there be any sale under a deed of trust, mortgage, pledge, or other security; nor under any judgment, decree, or order for the payment of any money, while this act remains in force, unless by consent of parties.

Provided, That no part of this act shall apply to the cities of Norfolk and Portsmouth nor to the counties of Accomac, Northampton, Norfolk and Princess Anne-but the act entitled an act staying the collection of debts, passed January 23d, 1865, and the amendment thereof, passed June 23d, 1865, shall remain in force so far as the said cities and counties are concerned, with the exception that sales of property may take place under the judgments and decrees of courts in cases where the collection of debts is not the object of such sales.

If any execution shall have been levied before the passage of this act, the property levied on shall be restored to the defendant, but shall remain subject to the lien of the execution aforesaid.

This act shall be in force from the passage thereof, and shall so continue during the present session of this General Assembly, unless sooner altered, amended or repealed

DEATH OF THE KING OF BELGIUM.

The last returns from Europe announce the death of a man whose name had been longer before the world than that of any public man whom he has left behind. LEOPOLD, King according to the constitution and laws of this of Belgium, died in Brussels on the 9th day of December. When we saw the announcement, our mind seemed to be carried back half a century, to the days of Napoleon I. and George III., of Francis Alexander and Frederick William III, of Wellington and Metternich, Canning and Castlereagh, the Conference of Erfuth, and the invasion of Spain, the invasion of Russia, and the invasion of France, the downfall of Napoleon and the Treaty of Vienua, the formation of the Holy Alliance, and the visit of the Sovereigns to England. To all appearances, Germany was subdued. It is probable, at least, that he tho't so; for we find from Napoleon's conversations at St. Helena, that he was at one time desirous to become one of his aids. He seems to have been wretchedly poor; for when the allied sovereigns made their celebrated visit to London, in 1814, after the downfall of Napoleon, he was extremely desirous to accompany them, but would have been prevented from the absolute impossibility of rigging himself out in the proper style had not his wants been supplied by a private hand. He did go, however, and there, for the first time, fell in with the Brincess Charlotte of Wales, heiress of the British Crown. The hand of this young Princess had been designed for the Prince of Orange, but, after having scen Leopold she could not be induced to marry him. She seems, indeed, to have fallen in love with Leopold at first sight. They were married ; and Leopold, who, at one time, had boarding house in London; had every prospect of becoming Prince Consort of the most brilliant crown on earth, when his hopes were suddenly blasted by the death of the Princess in child-bed. This event threw the whole kingdom of Great Britain into mourning; for, loyal as the English generally are, no prince or princess had ever been so popular as Charlotte ; who appears, indeed, to have richly deserved all the affection so profusely lavished upon her by the people. From that time, for many years, the name of Leopold very rarely occurs in the history of Europe.


