IMPEACHMENT. The Radicals, it seems to us, are bent on impeaching President Johnson. They will make sufficient expulsions in both the Senate and the House to secure a certain majority and then they will make up their case againstthe President and carry it through at all hazards, and at the expense of all Constitutional provisions. If this is done, will the people of the North stand it? Will the President submit to it? We think not. We fear that it will inaugurate another civil war even far bloodier than the one through which we have just passed, and which will only end in the complete destruction of the negro race, or in its absolute supremacy, civil and political. If this war is waged, we of the South will be compelled to take sides; and will, of necessity, be found, en masse, with the President and his conservative supporters at the north.

THE COUNTY SEAT. · Among the many laws passed by the late Legislature of West Virginia, there is none that works greater injury to the people of Jefferson than that establishing the county seat at Shepherdstown. The wishes of the people of the county certainly were not consulted. We venture the assertion that outside the election precincts of that town, there cannot be found much more than a score of men who favor the new location, and, sooner or later, the people will insist upon a change. In this view of the case it must be regarded as unwise to tax our citizens for the erection of new county buildings, as we understand the Board of Supervisors intend doing .-Charlestown is the only central town; and the public buildings here, which were so wantonly injured by the federal troops during the war: can be put into good condition again for a much less sum than will be necessary to expend at Shepherdstown. The people ought to take hold of this matter.

101ST ARTICLE. It is expected that the Hon. Charles Sumner will propose a new amendment to the Constitution, which will make the 101st of this series of laws for the new state of affairs. We have not been apprised of the exact phraseology of this proposed article, but it will provide, in effect, that hereafter no new State, including those lately in rebellion, shall be admitted into the Union until it shall have embodied into its constitution an irrepealable section requiring white persons to flog at night all the frog ponds within the sound of the residences of the freedmen; and it shall be the duty of the Commander in Chief of the Army and Navy of the United States to see this law thoroughly executed. As this article will secure peace to the better race of people in this country during their slumbers. it will, of course, commend itself with great force to the dominant party, and will become a fixed law of the land.

FIRST CASE UNDER THE CIVIL RIGHTS

At Fayette, Ind., on the 11th inst., a colored man named Barnes brought suit against a prominent citizen to enforce a contract .-The defendant, for answer, set up that the negro came into the State in violation of the thirteenth article of the constitution of the State of Indiana, which, under pains and penalties prohibits negroes from coming into the State, and debars them from all rights to enforce contracts, etc.

The plaintiff demurs to the answer, maintaining that the thirteenth article is void and of no effect, because: 1. It is in contravention of the letter and spirit of the Constitution of the United States. 2. It is in direct conflict with the constitutional amendment abolishing slavery. 3. It is void under the first section of the Civil Rights bill, which gives to all persons born in the United States full right to make and enforce contracts, any law, statute, ordinance, regulation, or custom to ficent Providence, and, to her, every addithe contrary notwithstanding.

The court sustained the demurrer, and the defendant appealed to the circuit court, which

The case was submitted, and after argument of counsel it was taken under advisement. Judge Gest will probably render a decision at an early day. Under the second section of the Civil Rights bill he can only decide in favor of the negro, for the reason that an adverse decision would subject him to the penalty of one thousand dollars' fine and imprisonment

We are rather gratified that the first case under this obnoxious measure has arisen in a Northern State, as it is probable that the white people in those States will be thus aroused to a sense of duty to their own race, and will visit upon the radical representatives who enacted the bill a sentence of condemnation, when another opportunity to vote is presented.

DEATH OF DANIEL S. DICKINSON.

This statesman, who has occupied a prominent place in American history for the last quarter of a century, died at his residence in the city of New York, on the 12th instant .-Perhaps no man who ever filled the position of United States Senator, was more popular at one time with the Southern people than Mr. Dickinson, on account of his fearless advocacy of their rights, but during the war he yielded to the strong current of popular sentiment in his own section, and became a most unrelenting advocate of a vigorous prosecution of the war. A few weeks ago we showed, from the text of the Constitution, that the denial of representation to the States of the South had destroyed the congressional character of the ges sitting in the chambers of the Federal Congress. If any formulary can be held necessary to complete the absolute right of representation guaranteed the States of the South in the letter and spirit of the fundamental law, we presume the loosest believer in the rights of the States must con-fess that that formulary has been supplied in the President's proclamation of peace. Peace declared officially to reign from one end of the country to the other, the States declared officially to be all, except Texas, ompletely restored to their original relations to the Federal Government, the exclusion of eleven States from representation by a tyrannical majority, is an act of revolution which has, plainly, stripped the men committing it of all authority in constitutional law.

The men who occupy the Legislative chambers of the Capitol do not, we repeat, constitute a Congress. Their deliberate denial of epresentation to eleven States of the Union, form. nas, clearly, destroyed the distinctive feature of the Congressional existence-general renresentation. As the sworn guardian of the right of the States, 'it is, therefore, the ounden duty of the President to use every lawful means of restoring these States to their place in the Federal Parliament. And. no other means being open to him for that act of constitutional duty, he cannot, unless he lend himself to the wrong by continuing to recognize the revolutionary bodies in the Senate Chamber and the House of Representatives, avoid the obligation to convene a Congress of the restored Union. The Southern delegations and the constitutionalists who passed through town, on their way to the up- now form the minority of the revolutionary President's call, and, throwing open their doors to all duly qualified members, will, from that hour, have become the Congress of the United States. Less than a quorum though they might at first be, they would, from the moment of their assemblage, have power to compel the attendance of others: and though in the end the revolutionists would probably constitute a majority in both chambers, the country would, at all events, have thenceforth been blessed with the fact of a restoration of the Union! This is, we necessities of political repose demand it; the legislative wants of the country call for it; and hold though it be, let Mr. Johnson remember that no man who has dared, as he has done, to cross the Rubicon of the revolutionary power, can sustain himself unless he rush on in resolute adoption of the Roman text: Quid times? Casarem vehis! [New York News.


