Others assign the radiant point to the constellation Orion.

The demand in Europe will be as in the United Sates, so great as to run prices to unprecedented figures, by making the leading countries rivals in purchasing, in such sections as possibly may have surplus. The condition of the crops in European countries makes the prospect still more unfavorable for the United States, as sarcity there opens a new field for speculations in this country, who will of course send their surplus to European markets, if the prices shall prove better there than in American markets. The prospect wears a very discouraging aspect for the public at large.—

The Marshat and other officers of the Police of Bultimore city and all incumbers of the existing Police of said city, are hereby attrictly ordered and required not to obey any orders that have unanated from the late Board of Police of said city since 10 o'clock this muruing or any orders that may emanate from said late Boards at any time hereafter.

The courts are open, an appeal to them can be speedily heard and all official rights determined. This course must be pursued. An array of force for any purpose of this kind is an unlawful assembly. The parties engaged in it are guilty of a breach of the peace and must be immediately arrested. All the powers of this court, shall be exercised with vigor and promptiess to prevent such a vio-lation of law and the public peace shall be preserved at all hazards.

The facts that persons claiming rightfully. or wrangfully to be Police Commissioners, are about to place persons on the streets as police officers, charged with the duty of preserving the public peace, is calculated to alarm the public mind. The dread of collision between the two forces, and of ultimate armed conflict, will fill the minds of peaceable and orderloving citizens with terror.
