Why Grant Dislikes the Jews. A correspondent of the Chicago Times

says :- The question is often asked, "What has General Grant against the Jews ?" "Why did he issue that notorious proclamation driving all Jews, without discrimination, outside his encampment," And not having seen published any satisfactory answer, I will give you what I suppose to be the real cause of his dislike to the Jews. During the winter of 1858 and 1860, while Grant was living at Galena, he took it into his head to go into business on his own hook; and thinking there was a speculation in buying dressed hogs and shipping them to Chicago, he came down to the town of Bellevue, lying soms 12 miles southwest; on the west bank of the Mississippi, for the purpose of buying from the farmers as they came in town with their pork and having it hauled to Galena, and there shipped on the railroad to Chicago, or in any other way disposed of so as to make a profit, which was very honorable, and, if managed understandingly, could have been made a profitable business. There lived at that time in Bellevue a man by the name of Rosenthal, who was a Jew, who was in the pork trade, and of course, would be glad to keep the trade in his own hands; so he determined, if possible not to give Grant much of a chance, and the first two or three loads were bid up far beyond its real value, and finally sold to Grant. By this time Rosenthal discovered that Grant knew no difference between the price of light and heavy hogs, when in reality, there is a difference of at least one dollar per hundred heavy hogs being the most—the hogs already purchased by Grant heing light, and he having paid the full price for heavy hogs. So Rosenthal goes to his warehouse, selects out all the light hogs, enough to load three or four wagons; gets some farmers who had wood racks on their wagons to load on the hogs, drive out of town by another street and come in the main road, to the corner where they were buying. Rosenthal meets them there by another street, and commenced bidding against Grant, and, after bidding the pork to the value of heavy pork, it was sold to Grant.—But the joke or "sell" being too good to keep, it was not half an hour before nearly everybody was splitting with laughter to see how the Jew sold the Galena pork buyer, which so disgusted Grant that he went home that night, and was never seen in Bellevue after.

Destruction of Tenacious Weeds

Every one at times has to contend with some noxious weed, which seems to defy all attempts to eradicate it; yet the most tenacions of life may be destroyed by a persistent criting away of its foliage two or three times a Many farmers have experienced this fact without knowing the reason, and hence we

It is as impossible that a plant should live long without foliage, as for an animal to faist without lungs: Gut away the leaves and the plant dies of a consumption, for which no physician, even if his "sands of life" we well nigh "run out," has been able to find a remedy. The plant draws only the elements of existence from the soil. These are vitalized in the leaves and this extent he accomplished One afternoon Hemlock concocted a palatable fancy drink, and just as he was about to place it to his lips, a lady customer entered, and he was compelled to forego the pleasure of imbibing until she had been waited upon. Some very persistent pests, like Canada thistle, yellow surdragon, sorrel, will often take two years cradicate by this process, but the result sure if the practice be persevered in.

SHEEP'S TONGUES STEWED .- Put them into cold water and let them boil; when they are sufficiently tender to remove the skin easily, take them out, split them, and lay them in a stewpan with enough good gravy to cover them. Chop parsley, and mushroom, with a little eschalot finely, work a lump of butter with it, and pepper and salt to flavor; stew them in the gravy until the tongues are tender, lay them in a dish, strain the gravy and pour it hot over the tongues, and serve.

THE NOMINATIONS.

OF MISSOURI.

The nominations made by the National Democratic Convention last week, have been well received so far as we have seen any expressions of sentiment from the Democratic press of the county.

Hon HORATIO SEYMOUR the candidate for the Presidency, was born in Onondaga county, New York, in the year 1811, and is consequently about 57 years old.

Mr. Seymour received a liberal and thorough education in the best institutions of the State : His instincts and preferences led him to the study of the law, which he pursued with great vigor and industry. He was admitted to the bar when little more than twenty years of age, and at once commenced the practice of his profession in the city of Utica. The death of his father, however, soon afterwards develved upon him so great responsibilities in connection with the settlement of the family estate, as to require the most of his time and attention, obliging him, much against his wish, to relinquish the practice of his profession. Up to this time Mr. Seymour had acted no prominent part in political life, although from his youth, as were his ancestors before him, he had always been strongly attached, through sympathy and taste, to the Democratic party. In the fall of 1841, when not thirty years of age, Mr. Seymour consent ed to the use of his name as a Democratic candidate for member of Assembly. Although the Whies were at that time largely in the ascendancy in Utica, Mr. Seymour was triumphantly elected by a large majority.

In the spring of 1842, Mr. Seymour was elected Mayor of the city of Utica, despite the continued hostility and opposition of the Whigs. In the fall of 1843 he was again elected a member of the lower House of the Legislature, and was re-elected to and served in the same position during the session of 1844 and 1845.

For the succeeding five years Mr. Seymour was not prominent in public life, having resumed the practice of law in the city of Utica. By the action of the Legislature of 1850, providing for the enlargement and improvement of the Erie Canal, and appropriating the revenue of the State in contravention to the provisions of the constitution, Mr. Seymour again assumed a leading position in State politics, and most earnestly resisted this effort to override the provisions of a constitution so recently adopted. On account of his strenuous opposition to that measure he was that year (1859,) for the first time, placed in nomination for Governor of this State, in opposition to Washington Hunt. The result of the elections wa: For Seymour, 214,352 votes; for Hunt, 214,614. Mr. Seymour having been defeated by 262 votes.

In 1852 Mr. Seymour was again placed in nomination by the Democratic party, in opposition to Washington Hunt (Whig) and Minthorne Tompkins (Free Soil,) with the following result :

Seymour......264,121 | Tompkins,..... 19,299 Hunt,239,789 In 1854, Mr. Seymour was again a candidate for Governor, but was defeated by division in the party.

In 1862 Mr. Seymour was for the fourth time placed in nomination for Governor of this state by the Democrats, against General Wadsworth, the Republican nominee. The result of the election was as follows:

elected Governor of the State by the handsome majority of 10,752. Atter an able administration of two years he was, in 1864, nominated for re-election; this time against Reuben E. Fenton, by whom he was defeated Of the candidate for the Vice Presidency, Hon, FRANCIS P. BLAIR, we have not the room in this issue to furnish a biographical sketch. His present position is admirably set forth in a letter which we publish elsewhere to-day.

THE COUNTY CAMPAIGN.

We published last week the proceedings of the Conservative County Convention, held at Harper's Ferry, on the 6th instant. We were present at that Convention, and were gratified at the spirit evinced. It gave us renewed hope that the rascalities and frauds of the unprincipled radicals who have ruled this county, are to meet with a resistance that must result in their overthrow. There were men there who have heretofore quietly submitted to these outrages, but who are now alive to their own interests, and who mean to have their rights, or visit the just consequences of their disfranchisement upon the heads of the unscrupulous emissaries of radicalism, who have estracised them merely because they could not control them in the inerests of the radical party. We may expect ome bitterness in the campaign upon which we are entering, but the Democratic party of this county does not mean to submit longer to the unmitigated scoundrelism of Boreman and his appointees, and it may as well be understood in the outset, by the Board of Registration, that Joe. Chapline and Anthony Turner cannot deprive men of their rights, on the flimsey pretext that they are not loyal, because they have the independence to think and act for themselves. If they make such en attempt, things will become too warm for them to find a resting place within the boundaries of this county. And we say this in no spirit of bullying bravado, but give it as the feeling which we believe actuates every mem ber of the party who has suffered wrong a he hands of these corrupt and unprincipled

If the radical party can carry this county y fair means and a legitimate registration, no word of objection will be uttered, and no act of violence perpetrated, but if they persist n continuing the frauds which have heretofore marked their career, they will not find a tame submission. Already Chapline and Turner have made their boasts of what they ntended to do, and have publicly declared that if it becomes necessary to secure success to their ticket, one hundred and fifty names will be stricken from the list of registration This is the spirit with which they enter the campaign, and this must be met by the opposit party with a determination not to allow such threat to be carried into execution.

On Saturday week the representatives of he different townships will meet in this town for the purpose of nominating candidates for the Legislature and the various county offices. The men placed before the people by this contemplated Convention, are not to be cheated of their elections by the nefarious schemes heretofore resorted to to secure radical success. When men allow their names to be used to promote the interests and attain the success of a party, they do it with the presumption that the party will not only sustain them with their votes, but with the expectation also, that the party will protect them from the frauds and corruptions of their pponents, And this much the Democratic party will owe to its candidates. They must sustain them at the polls, and see that every man entitled to vote casts his ballot; and they must further see that no spurious ballots are cast for their enemies.

Past experience has taught us that there is no meanness; no trickery; no corruption, no dishonesty, to which the radical party in this county will not readily resort, if they are not inspired with a wholesome fear of the conse quences. GEN, BLAIR, S POSITION. The position which Gen. Francis P. Blair as been assigned on the Democratic ticket gives additional importance to the annexed letter, previous to the meeting of the Convention, when his name was mentioned as a candidate for the Presidency :--

WASHINGTON, June 30. Colonel Jas. O. Broadhead. DEAR COLONEL: In reply to your inquiries I beg leave to say that I leave you to determine, on compultation with my friends from Missouri, whether my name shall be presented to the Democratic Convention, and to submit the following, as what I consider he real and only issue in this contest

The reconstruction policy of the Radicals vill be complete before the next election : the States, so long excluded, will have bee admitted; negro suffrage established and the carpet baggers installed in their seats in both branches of Congress. There is no possibility of changing the political character of the Senate, even if the Democrats should elect their President and a majority of the popular branch of Congress. We cannot therefore. undo the Radical plan of reconstruction by Congressional action; the Senate will continue a bar to its repeal. Must we submit to it? How can it be overthrown? It can only be overthrown by the authority of the executive, who is sworn to maintain the Constitution, and who will fail to do his duty if he allows the Constitution to perish under a series of Congressional enactments which are in palpable violation of its fundamental prin-

If the President elected by the Democracy enforces or permits others to enforce these Reconstruction acts, the Radicals, by the necession of twenty spurious Senators and fifty Representatives, will control both branches of Congress, and his administration will be as powerless as the present one of Mr.

There is but one way to restore the Government and the Constitution, and that is for the President elect to declare these acts null and void, disperse the carpet-bag State government, allow the white people to reorganize their own government, and elect Senators and Representatives. The House of Representatives will contain a majority of Democrats from the North, and they will admit the Representatives elected by the white people the South, and with the co-operation of the President it will not be difficult to compel the Senate to submit once more to the obligations of the Constitution. It will not be distinctly invoked and clearly expressed, on this fundamental issue, and it is the sure way to avoid all future strife to put this issue plainly to the country.

I repeat that this is the real and only ques tion which we should allow to control us Shall we submit to the usurpations by which the Government has been overthrown or shall we exert ourselves for its full and complete restoration. It is idle to talk of bonds, greenbacks, gold, the public faith and the public credit. What can a Democratic President do in regard to any of these with a Congress in both branches controlled by the carpetbaggers and their allies? LOCAL MISCELLANY.

on last the Main street of this town was the theatre of a most disgraceful riot, which preves that our community is without law, without the officers to execute it, and completely at the mercy of uce. Why this is so, and why, as a consequence, the life of every citizen is in danger, it would be a profitless job now to enquire. We only know that the radical Legislature of the State has refused us a charter for autolopal organization, whilst an amiable Board of Supervisors has planted grogshops upon nearly every corner, and placed them, to some extent, in the hands of parties who care not what the result may be, if only

they can sell their liquor at a heavy profit.-The riot of Saturday afternoon is traceable to liquor, for without it the negroes never would have assumed the defiant attitude which they did, and which they maintained until they found they had aroused a feeling of indignation that was likely to result in the severest

punishment, even if life itself was not taken. How the fight commenced, or what it commenced about is a question about which every man has his own opinion, hardly any two agreeing as to its real origin, except that liquor furnished the fuel by which the flame was kindled. Harvest having just ended, the negroes flocked to town on Saturday morning to divest themselves of the money they had earned, a considerable portion of which they spent in the drinking houses of the town. As a matter of course they were crazed by the influence of the ardent, and during the whole morning they were moving about the streets with insolent airs, and using abusive, obscene and profane language. This was naturally calculated ts provoke a conflict, for however the case may be elsewhere, this community is not yet ready for submission to negro insolence. Before noon, Deputy Sheriff J. D. Potterfield arrested a negro who was strutting the streets with a cavalry revolver buckled around him on the outside of his coat. After his arrest, he openly announced that he was carrying this weapon for a white man, with whom he had had a difficulty in the harvest field several days previous, and declared his purpose to shoot the white man if he found him. This negro was taken to the office of a magistrate, but the magistrate was absent and his office door locked. The negro was released, and a few hours later in the day was among the rioters on the street. Befween 2 and 3 o'clock some young men were sitting on the boxes in front of the store of Mr. Jacob B. Brown, when two negroes came out of the store. A trivial circumstance led to words between the parties, and from words to blows; one of the negroes was knocked down by the fist, and another with a stone. The negroes then ran up street as far as the store of Trussell & Co., followed by the white men. Here the negroes halted. and called for their color to rally, which they did with promptness and spirit, rushing down from the different corners with a tiger-like ferocity, until about thirty had reached the spot. A young white man named Codrick. who was in the commencement of the difficulty, finding himself about to be overpowered retreated into the store, and the negroes attempted to tollow him but were met on the pavement, and entreated to desist, and efforts made to quiet them by expostulation. But they were deaf to any words of advice, and swore they would have Codrick, who in the meantime had slipped through the store, and passed out the back way, for the purpose of arming himself. For several minutes the negros who seemed to be greatly enraged, stool in the street cursing white men generaily, throwing off their coats, and daring a conflict. At this time the number of whites immediately present was not more than five

mate, must have numbered thirty; each one vehicmently swearing and gesticulating in the mist arrogant and defiant manner. Mr. James with a rake, felling him to the ground. Then commenced an indiscriminate fight, maintained at first by the white men at great odds -at least five to one, until the citizens of the town gathered at the scene. A complete rock battle raged for the time, and furiously the races assailed each other. We are sure we never saw a fight in which so many men were knocked down in so short a space of time and we sicken as we contemplate the scene of crushed heads and bleeding faces With a sort of reckless desperation, the negroes contested the ground, throwing their missiles with remarkable precision of aim.

uatil they saw that they were about to be overcome, when they bolted in different directions, and at the expiration of ten minutes hardly one was to be found upon the street. By a mercy which appears inscrutable, no one was killed, although several severe wounds were received. Among the whites who were more or less injured, were the following :-James N. Gallaher, George Robinson, Wm. Moore, John sheets, J. H. Morris, and perhaps others. All of the above, we are glad to say are doing well, though saffering from their wounds. Among the negroes who received injuries were Wesley Lowrey, John Jackson, Sam. Ranson and Carter Fisher. How seriously these latter have been punished we have no means of knowing, as only Lowrey has been seen since the difficulty. A while before night, Sheriff T. W. Pot-

terfield, who had been telegraphed to, arrived from Harper's Ferry, bringing with him a posse of armed men. The names of the leading rioters were given him, when he proceeded to make arrests. Soon Wesley Lowrey, Jim Jackson and Bill Taylor were in custody, and late on Saturday night an examination was had before justice elicited in the opinion of the justice, warranted their retention, and a further examination was postponed until yesterday. LATER.

Yesterday morning Carter Fisher, negro, one of the leaders in the riot, was arrested and brought to town. John Jackson and Sam Ranson, have not yet been-arrested, but rumor has it that they have escaped to Mary-land. Both of these were conspicuous in the fight of Satarday fight of Saturday. THE LATEST.

At the examination yesterday, before Justices Myers and Ridenour, Ranson and Jackson came and gave themselves up, and their cases were taken up and disposed of with those of the other parties under arrest. The parties on trial were each held to bail in the following sums, to answer the charge of rioting, at the October term of the Circuit Court:

Jim Jackson \$50, and Carter Fisher, Sam. Ranson and John Jackson, each in the sum of \$200. Up to the adjournment of the Court, none of the parties had given the required bail, with the exception of Jim Jackson, Esquire Ridenour becoming his bondsman. The examination was conducted by Tiph W. Karrada E. Carte W. John W. Kennedy, Esq., for the State, Wm

H. Travers, Esq., appearing for prisoners. In this whole affair it has given us pleas to witness the efficiency of the Messrs. Pot-terfield, the Sheriffs, as contrasted with the inefficiency of our own elected conservators of the peace. These men came into our midst—leaving their own homes and families, and night and day labored assiduously for the maintenance of order, and in this they were sustained by the vast majority of our citizens.


