was to proceed to Seal Cove in the island of Grand Mann, off the coast of Maine, for coal, and there hand the vessel over to Capt. John Parker, my superior officer. In making the capture I detailed Lieut. Cowins and two men to take charge of the engine and fire-room. The engine-room communicated with the cabin by a door on the port side: After seeing the men go into the engine-room I passed forward, Lieut. H. A. Parr having charge of the deck in my absence. While forward I heard a shot fired in the engine-room, and at once went aft through the cabin into the engine-room, and thence into the fire-room, where I f und the fireman SS. in irons Returning to the deck I found no NG one in the engine room, but much to my regret, I saw the body of the second enginee of the Chesapeake lying across the threshold of the door. Gring forward I found Lieut Cowins, who reported to me that when he

went into the engine room the engineer was below oiling the machinery, but after securing the fireman he found that officer at his nost He ordered the engineer to surrender as a prisoner of war to the Confederate States of America, and that officer replied by fifinga shot which mainied one of the men for life. I had no arms except Colt's revolvers .---On arriving at Seal Cove, after the capture, I found that my superior officer was not there. CAL. I remained about three hours, and then proceeded up the Bay of Fundy, meeting Capt.

Parker at sea, in a pilot boat, about 60 miles from St. John. N. B. The captain, officers, and some of the crew of the Chesapeake were transferred to the pilot boat and taken to St. John. Captain Parker then took command, and changing the course of the vessel, put into Shelburne. Nova Scotia, for the pur pose of coaling. While the vessel was in port I was ordered to Halifax to procure supplies, and I was never again on board the Besapeake in an official capacity. The ship was recaptured in San Bar Har bor, near Halifax, by the United States gun-

boat Elia and Annie. Capt. Nicholls, and taken to that city, where the original capture was abjured asan act of war. The vessel was handed over to the owners, Messrs. Cromwell & Co., of New York, upon a deposit of \$70; .000 being made to the British authorites, and Mr. Seward afterward made an apology for the recapture. In every case I issued strict orders to my

officers and men not to fire upon any one unless resistance was offered. At the close of the war I was in command of the Confederate States schooner St. Mary's in the West-Indies. Upon being informed of that event, I burned the vessel, and returned to this country in October, 1865, trusting for secu rity to President Lincoln's proclamation of amnesty

I engaged in business at Savannah, where my family now are. On th 13th of Septem ber. 1866. I was arrested at the Wall House. Williamsburg, and after being ironed, I was taken to the forty-fifth precinct stationhouse, where I was kept all night without

bedding of any kind. though I offered to pay liberally for it. I took a cold that night which has been the cause of much suffering. After being taken before the United States commissioner, I was sent to this prison, where I have been ever since, my case being continued from day to day and month to month without trial. I wish to repeat that I am not by any means the blood thirsty individual I



THE NEW ADMINISTRATION. Before this time next week, the country will be breathing its existence under the ad ation of General Grant, of whose genpolicy we have only the feintest foreabadowings. It is true, that in his brief speech inding to the official notification of his elevation, he gave out some expressions in remind to an economical administration, honesty in the collection of the revenues, &c., but upon the question which most deeply interests the whole country-the restoration of the States of the South, to their legitimate places in the government, which alone can insure general- prosperity and happiness-his outgivings have been too vague to form a probable estimate of what his real policy is likely to be. Upon this point then, we have only to wait and hope, let the developments of the future. be what they may.

But whilst this is the case, one feature has manifested itself in the character of Gen. Grant, which has created for him a better opinion in the minds of those who opposed his elevation to the Presidential chair. He black ? has kept his own counsels, and kept them well, and in this has demonstrated his own self-reliance, which has kindled a lively hope that he does not mean to be a mere instrument in the hands of the radicals, to be moulded as olay in the hands of the potter. If it be true that he said to Mr. McClure of Penn, last week. "I am not the representative of a political party myself, although a party voted for me," unquestionably entertains a high estimate of the position to which he has been called by the voice of the people, and may rise superior to the circumstances which surround him, and do much to calm the troubles and avert the dangers into which Radicalism, in its insatiate lust for power, has plunged the country. 

But between our condition under the almost perfect form of government bequeathed us, and the present chaotic state of the country, under radical control, there is so wide a margin that there is great room for decided improvement, without attaining the perfection of the former or persisting in the madness of the latter. We do look for that improvement; May we not be disappointed. -

Since writing the above, we have read the following in the Petersburg Index, which so well expresses our own views, that we embody it as a part of this article :-

There are heart-burnings, political fueds, mental anxieties and disquietudes which need to be allayed. These are not war but they breed war. They corode, they exasperate, they inflict a mental torture from which to escape into open war is a positive relief. It is to those that General Grant must address the healing measures of a magnanimous policy, if he would give us peace. Should he fail to do so, there may brood over the country a stillness which is not repose; one of those portentous calms like that in which, nature eilently elaborates the forces of storm and tempest, which are the more destructive the longer she delays to unleash her thunderbolts and send the tornado careering in its wrathful might over the tropic seas.

DISABILIT ES, OF VIRGINIANS.

In the Reconstruction Committee, on Wednesday last, the amended Senate bill removing disabilities was considered, and considerable progress made; the committee accepting many of the names put on in the Senate, and rejecting some few, among them that of B. H. Shackelford, of Fauquier county, Virginia, which having met with considerable opposition, was stricken off. The name of Judge Richard Parker was retained by the committee, of whom seven were present at the meeting this morning, the vote standing four for retaining and three against, Bingham voting for the Judge's retention. No names were added to the bill as it came from the Senate. The names of several persons recommended by the Richmond Badical Committee have en advanced on the new bill in preparation.

The Fifteenth Amendment to the Constitution, which has been for some time under posideration by Congress, was finally passed by the Senate on Friday, by a vote of 39 yeas to 13 nays. Mr. Gaurett Davis made a point of order that it required to carry the amend-ment a voie of two thirds of the whole Senacts. ate, but it was not allowed. As both Houses have now possed the amendment by what is alleged to be the requisite vote, it now goes to the State egislatures for ratification or rejection. This proposed amendment as adopted is as follows :

"Be it resilved, &c., (two-thirds of both Houses confurring,) That the following amendment to the Constitution of the United States be sub nitted to the Legislatures of the several State; and when ratified by threefourths there if it shall be a part of said Con-






