Do not make mistakes in this matter. You are a great, powerful nation, the greatest that the world has ever seen. You have forty millions of people, and you are the strongest nation the sun ever shone upon. The rivers of South America are broader and deeper than ours. There groves are spicy, and their fields groan with the riches of the earth, yet they have no rank among the nations. They made the same mistake which the Republicans are now making, and incorporated an inferior race into the body politic. It led at last to an admixture, and finally to equality, and those great countries are inhabited by mongrels, and yet they are countrymen of Columbus and the descendants of the followers GEN. excellent opportunity of comparing the industry or the Chinese with that of other nations As a free port, Singapore is open to immigration from all parts of the earth, on equal terms. There are no jealous laws, guilds or monopolies to shackle the limbs or weaken the energy or enterprise of any one. Free competition is the presiding genius of the place. The climate is healthy. The English call it the Madeira of the East, and the European artizan can labor in it as well as the East Indian or the Chinese. All nations flock hither to trade, as has already been remarked. Now, what is the result? Almost all the business of every description is in the hands of the Chinese. Large Chinese houses monopolize the trade, and the Chinese artizan and day laborer have driven out all others .--Ninety thousand of the one hundred thousand of the population are Chinese. "Now that the exclusiveness of China has

been broken in upon, and the emigration permitted, what a destiny awaits such a people in the workshops and fields of the Western World ! Already they are filling up the States on the Pacific coast, and silently, but surely, possessing themselves of the avenues of industry in these States, thrusting aside the more expensive European and American laborers. They will cross the Rocky Mountains, and effect, in course of time, a similar revolution in the Western and Southern States. In the latter States their success will be most triumphant; for in these States, where the negro is the chief laborer, the competition will be between frugality, forecast, and industry, on the one hand, and uselessness, indifference to the future, and laziness, on the other." When the tide of population and wealth which is now pouring into this country from the East, is met by the swelling flood of Asiatics from the West, the grandest conceptions of material progress of the statesman and capitalist of this day will sink into insignificance. The owners of real estate in the South should keep an eye to these movements in the West as well as in the East. In our

judgment, they point unmistakably, and at no distant day, to the rapid and permanent enhancement in value of Southern lands. The Mobile Tribune suggests that a subscription of half a million dollars be raised to inaugurate the movement of Chinese to that State.

He kept his potatoes through the winter in a large covered bin in the cellar; this bin would hold about two hundred bushels, and was so constructed that the bottom and sides were about six inches from the floor and

He had found from experience that potatoes would keep better if no light could reach them. One year he had more than his bin would hold, and threw the remainder into one corner of another cellar where they froze solid; as soon-as this was discovered they were well covered up with old clothes, carpets, &c., and came out in the spring as sound as if they had not been frozen, but a small portion planted for experiment did not grow. Another member had experimented in the size of the seed and manner of planting, and came to the conclusion that it was most profitable to use medium sized potatoes cut in four pieces and placed eight or ten inches apart in the furrow. He had tried large ones cut in two and in four, and with but two eyesin a piece; with medium-sized ones cut in two, and planted whole ; and with small ones planted without cutting, and could detect little difference in the yield. In each case the distance apart at which the sets were placed depended upon the number of eyes which they contained. He considers that an eye will produce a good stalk no matter whether it comes from a large, medium-size, or a small. potato ; thinks that a cutting should always be governed by the number of eyes and not by guess, as he has found potates of the size of a hen's egg with but two eyes, and others of the same size with more than a dozen. He thinks that one stalk every eight inches is enough, and if he plant more than two eyes in this distance we will have too many stalks to produce well; but to insure a plant he prefers to plant at least two eyes in a place and eight or ten inches assunder.

Another member had applied various topdressings to his potatoes with varied effect. flad used plaster, ashes, the two mixed, sait, salt and ashes, salt and lime, and salt, ashes and lime and in point of economy preferred the litter. He used five bushels of salt, ten of lime and ashes, for an acre, and applied to the hills by hand.

He always buried his potatoes in the field or some other convenient place, in long, narrow mounds, taking care never to get the potatoos more than four feet thick, and to leave openings in the mound until cold weather had set in. He finds it economical to plant pumpkins in the rows among the potatoes, the only objection being that the vines are somewhat in the of digging the potatoes.

By vote it w s resolved that the best and most economical plan to raise potatoes is to plant them in last year's corn ground with a good coat of long strawy manure either in the furrow or spread broadcast; use mediumsized potatoes cut in two or four for seed, and dropped eight or ten inches apart in the row. An acre should yield one hundred and fifty bushels of marketable potatoes and twenty five of small ones suitable for stock. In addition to this one of the members raises from six to eight cart-loads of pumpkins without | any additional expense except planting, say fifty cents for the lot.
