It has been estimated, (and we believe that no one who has carefully examined the estimate attempts to controvert it) that the excess annually paid for transportation, beyond reasonal le rates, by the existing means of shipment, of the products of this county, reaches the sum of fifty thousand dollars. That is to say, such competition as will reduce the costs of conveyance of the crops of the county to a fair and profitable standard will yearly save the large sum which we have just named. If then the two hundred and fifty thousand dollars of subscription should be, instead of a subscription, an actual gift, it will all have been recovered at the end of five years ; and from that period onward, for all time to come, there will be a yearly saving of fifty thousand dollars. Nor does this aspect of the case present all the advantages which will be reaped from this enterprise. In the wake of such im-

provements come population and the establishment of home markets for the consumption of home products. There will then be not only a reduction on the carriage to market, but there will be a condition of things which will supersede transportation at all to a distant market.

Now what is the sacrifice in the way of taxstion involved in the attainment of these most desirable objects ?

The subscription (\$250.000) asked from the county, will secure an equal amount of the stock of the Shenandcah Valley Railroad the county bonds or subscription must be met. Should, however, the road be pushed on rapidly to completion, as we have every assurance it will be, at the end of two or three years the payment of interest will practically cease-the dividends on the stock of the road enabling, and in all probability more than enabling, the county to meet its interest as it accrues. There will then be six per cent. bonds represented by a paying stock, and should the county desire to cease its connection with the road, it needs but to sell out its stock and pay off its bonds as they may become due. These bonds will doubtless be issued payable at long dates; and there is reasonable hope to believe that before one of them shall have become due its payment may, be provided for by the sale of stock held by the county.

Should this be the course pursued what will be the cost of this great work to the county ? Simply nothing more than the payment of two or three years interest or \$30,000 or \$45,000 at furthest. Nor must it be understood that this is to be set down as capital employed for which no return is made. 
