WAR DEPARTMENT, July 11, 1836.

"I have received and submitted to the President your letter of June 7th, together with the report made to you by Capt. Dean.

I am apprehensive from the tenor of this report, as well as from your observations, that the frontier has much to fear from the hostilities of the Ir. dian tribes living in Texas. On this subject it is proper to call your atten-tion to the instructions previously issued to you, and to say to you that if the conduct of the Indians in Texas threatens the frontier whose defence i entrusted to you, and you consider it necessary, with a view to its protection to advance as far as Nacogdoches, you will do so without hesitation. 
