THE LEGISLATURE OF VIRGINIA adjourned on Thursday last. We are indebted to Mr. KENNEDY, one of our late Delegates, for a list of the Acts; the publication of which will be commenced in our next. The Bank Bill passed on the last day of the session. It will be laid before our readers next week. In the meantime we give the following synopsis of it, for which we are indebted to the Baltimore American:

The Act provides that the forfeiture of their charters for refusal to pay specific amounts under existing laws, shall be suspended until the end of the next session of the General Assembly; and so much of any act as may prohibit them from issuing notes for sums of five and ten dollars shall be suspended until the first day of April, 1811. The amount of any note or debt due from any Bank, with legal interest thereon, may be nevertheless recovered in suit by the mode now common in the Commonwealths, which are now receivable in payment of debts and taxes due to the Commonwealths, are to be recovered in the same manner. The public revenue are to be made as heretofore in the Bank of Virginia and Farmers' Bank of Virginia, unless the Executive shall otherwise direct, in which case the Treasurer, with the sanction of the Executive, shall provide for the safe keeping of the public money.

The amount of the revenue of the State set aside for the payment of debts due to the Commonwealths, and for the payment of debts due to the State, which were arising from other officers "who had distinguished themselves in the late war," on the contrary, shall be annually voted to him by Congress, at the same time that the same was voted to Gov. Shelby.

She was a servant in the house of Mrs. FINE, and communicated the fire to the roof of the building in the middle of the day, while the family were on a visit to some of the neighbors.

The steamer "British Queen" arrived at New York on the 18th inst. from England. The most important news by her will be found enlarged in the Correspondence of the *National Intelligencer* in another column. The advices by this arrival are calculated to sustain the present price of flour in this country.
