

An interesting interview between Governor Koswith and Henry Clay took place on Friday, ni half past two o'clock, at the apartments of the latter, in Washington. Kossuth was incoduced by Senator Cass, and the correspondent of the Philadelphia North American gives the annexed account of what transpired on the occasion :

Mr. Clay received him standing; and then, being neated, on account of his feetle conditions, addressed the celebrated Magyar in a speech of half an hour in length, frankly expressing his opinions. He deprevated the policy of intervention as the greatest alamity which could befal this country, and said that, as the possessors of the only existing republic, the example of man's capacity for self-government, it was the duty of the American people to encouringe haman progress and prospering on this cortinent, which might be destroyed by foreign wars, involv-iug in their fall all hopes of free institutions. These were, he said, the sentiments of a dying man who had struggled for freedom.

Kossuch replied. He did not combat Mr. Clay's positions, but confined himself to the prospects of Hungary and the situation of France, believing that events in the latter country would terminate in civil war, and, perhaps, in a general revolution. Al parting, Mr. Clay rose and hade Kossuth fare

well for ever, wishing him a God speed for Hungarian independence as the reward of the noble efforts of her people. We have received the 24th Annual Report of the President and Directors of the Western Lunatic Asylum at Staunton. 
