TRADING BY RREE NEGROES. " If a free negro sell or barter, or other to sell or barter, any agricultural products, without having a certificate in writing, from one respectable white person of the county or neighborhood, of his belief, that he raised, or otherwise came honestly by the same, such products shall be forfeited and the negro te punished with stripes. And any white person who shall purchase, or receive in trade, agricultural products, of a free negro, who has not such certificate, shall be deemed guilty of a mi-demeanor. Such products shall, by order of the justice or court before whom the offended is convic ed, be sold by a constable or the officer of the court, like goods levied on, and the proceeds, after deducting a commissin of ten per cent, for the officer, shall be paid to the overseers of the poor for the county or corporation. This section shall not be in force in any county other than Accounted or Richmond, or in any corpo ration, until the county or corporation court, (the acting justices thereof being summoned and a ma-

ority of them being present ) shall so order." TRADING BY SLAVES. "If any person sell wine, aid at spirits, or any mixture thereof, or any other intexicating liquor, to a slave without the written coasent of his master, he shall forfeit to the master four times the value of the thing sold, and also pay a fine of twenty

"If any person buy or receive from, or sell to, a slave, without his master's consent, any other article or commodity whatever, he shall forfeit to the master four times the value of such articles or commodity and also pay a fine not exceeding twenty dollars."

I will not lend persons money and allow them to keep it as long as they wish, and when they see for deliver wheat to pay it with and then keep it on hand till they see fit to price it, and give them what they ask for it regardless of what I sold the flour for, to get back my money; in this case I claim the right of allowing such a price as it is worth when it comes to the mill. 2nd. I will not receive wheat under a compulsion of pricing it whenever called on according to prices given by boatmen when wheat is higher than flour; in this case I will pay for it according to the price of flour, freight off. 3d.
