OBSERVER. FRIGHTFELSTEAMBOAT EXPLOSION.

CINCINNATI, Sept. 1.-A few days since, just af-ter the steamer Timour, No. 2, had landed her pas-sengers at Edward's Yard, near Jefferson city, Missouri, her three boilers exploted, scattering death and destruction around, and leaving the boat a total wreck.

At the lastest accounts six persons were lying on the shore dead, and it was supposed that 15 or 16 others were thrown overboard an. drowned. (w-ing to the confusion and excitement the exact numper of killed could not be ascertained. About seventeen persons were scalded and otherwise injured-Mr. Dix, the pilot, was in a dving condition, not naving spoken since the explosion. Among the killed are Wm. Kilcher, Ed. O'Mahey and Conners. Among the wounded are Patrick Finney, deck hund, badly scalded; Edward Roach, deck hand, scalded; three children of Mr. Charles Eckley, he second clerk, scalded ; Mr. White, a merchant of Roanoake, scalded. Eckers, the clerk of the boat, had his family on board, and two of his chil-thrown on mercely scalded. The injured men are river. "The great mistake of all is to put on top much coal, as if it were wood-the greater the quantity the greater heat. If too much coal is supplied, the

combustion is necessarily imperfect, because the fire is "chocked up," the draught destroyed, and the elements of the coal, slowly escaping from it, pass off to the chimney unconsumed, or are disseminated in gases throughout the room. Whereas, if the strata of coal be but moderate, a red flame will play around the interior of the stove, by which entire combustion and a heatlhy heat are secured. One ton of coal, therefore, by thorough combustion, will often secure more heat and a healthier atmosphere, than two tons consumed in the ordinary way; and this is a fact which can easily be demonstra-

They had won them not only by the sweat of their brow, but by their blood. This is the true history of the difficulties at Rome about the public lands, and I will now quote that history as sanctioned by the authority of Mr. Calhoun in the 1st vol. of his work on government, and at page 92. It is as follows : was lost in a deluge of fire.

"It is well known to all, the least conversant with their history, that the Roman people consisted of two orders, or classes—the Patricians and the Plebeians; and that the line of distinction was so strongly drawn, that, that the line of distinction was so strongly drawn, that, for a long time, the right of intermarriage between them was prohibited. After the overthrow of the monarchy and the expulsion of the Tarquins, the government fell exclusively under the control of the patricians, who, with their clients and dependants, formed, at the time, a very numerous and powerful body. At first, while there was darger of the return of the exiled family, they tracted the pichejans with kindness; but after it bud

there was darger of the return of the exiled family, they treated the plebeians with kindness; but after it had passed away, with oppression and cruelty. "It is not necessary, with the object in view, to enter into a minute account of the various acts of oppression and cruelty to which they were subjected. It is suffi-cient to state, that, according to the usages of war at the time, the terribry of a conquered people became the property of the conquerors; and that the plebeians were harassed and oppressed by incessant wars, in which the danger and toil were theirs, while all the fruits of vic-tory, (the lands of the vacquished and the spoils of war) accrued to the benefit of their oppressors. The result was such as might be expected. They were impover-ished, and forced, from necessity, to borrow from the patricians, at usurious and exorbitant interest, funds with which they had been enriched through their blood and toil; and to pledge their all for repayment at stipo-lated periods. In case of default, the pledge became forfeited ; and, under the provisions of law in such cases, the debtors were liable to be sourced, and sold or impris-oned by their creditors in private julis prepared and kept the debtors were liable to be seized, and sold or impris-oned by their creditors in private juils prepared and kept for the purpose. These savage provisions were enforced with the utmost rigor against the indebted and impover ished plebeians. They constituted, indeed, an essential part of the system through which they were plundered and oppressed by the patricians. "A system so oppressive could not be endured. The natural consequences followed. Deep hatred was en-gendered between the orders, accompanied by factions, violence and corruption, which distracted and weakened the government. 


